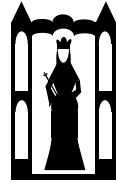

**Notification of proposed works to trees in conservation area**

**Proposed Silver Birch T1 - Crown reduction to the previously reduced tree, back to approximately 1 - 1.5 metres above the previous points or to a suitable pruning point. Sycamore T2 & Sycamore T3 - Pruning of the neighbouring Sycamores - For the crown raising of the two large trees owned by The Bell over hanging the garden, remove the lowest laterals to make the trees more vertical over the customers garden. Lifting to approximately 3 - 4 metres above crown level and reducing the higher laterals (to adequate pruning point) by approximately 1.5 - 2 meters.**
